The Association has reviewed the tax positions for the open tax years (current and prior three tax years) and has concluded that no provision for income tax is required in the financial statements. There were no unrecognized tax benefits identified or recorded as liabilities during the period covered by these financial statements. Forms 990 are filed by the Association and are subject to examination by the Internal Revenue Service (IRS) up to three years from the extended due date of each return. Forms 990 filed by the Association are generally no longer subject to examination for the years 2010 and prior.

Each employee has an evaluation by their supervisor on their anniversary date and is given a raise based on their merit. This raise recommendation then goes to the Executive Director for approval. The Executive Director is reviewed annually by the Executive Committee and their recommendation is approved by the Board of Directors, and duly noted in the minutes of the board meetings. One or more compensation surveys are gathered each year. We have used the Survey "Compensations for Not for Profits" by ADP and the Child Care Association of Illinois as examples.
