Residential - LCFS is committed to helping children and youth, especially those who are at risk We have two residential programs for youth who need specialized help They are Lutherbrook and Southern Thirty Adolescent Center (STAC) Lutherbrook Child and Adolescent Center provides specialized residential treatment for children and adolescents with severe emotional and behavioral difficulties (stemming mostly from child abuse and neglect) Lutherbrook helps them learn to trust others and form positive relationships, especially with adults The goal of treatment for each child is to resume family and community living Additionally, we provide educational services Lutherbrook Academy serves children age 5-21 who have severe learning disabilities (LD), behavior disorders (BD), social/emotional disabilities (SED) and high functioning mentally impaired children who are also LD, BD or SED Southern Thirty Adolescent Center (STAC) is a 30-day shelter and diagnostic program for adolescents 11-17 STAC provides emergency shelter care, clinical assessments, counseling and family intervention
