Behavior modification, counseling, and other supportive approaches are used to help students develop the necessary skills to return to their home school. For the year ended June 30, 2014, 4,650 child days of service were provided to 42 students.**4b** (Code:) (Expenses \$ 599,048 including grants of \$) (Revenue \$)GroundworkA domestic violence program for battered women and their children. Program provides emergency shelter, counseling, and social services. The shelter is open 365 days per year, 24 hours per day.
