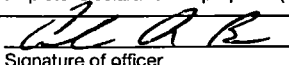

IPHCA provides training, maintenance, and software support services for for an integrated Practice Management/Electronic Health Record/Electronic Dental Record system that 17 Federally Qualified Health Centers with delivery sites in medically underserved underserved areas utilized during the year.

The goal of the network is to allow participating health centers to continue the services they provide to their community while realizing significant cost savings and benefits as a result of being part of a collaboration. The network facilitates further integration and use of new technologies to enhance communication, trust, and renewed working relationships between diverse health center partners.

The network helps foster a working environment among health center partners, allowing for the free exchange of ideas and information between entities hundreds of miles away. It creates additional commonality among partners and will eliminate old excuses for not working together on common ground issues.

IPHCA provides training and technical assistance (T/TA) to potential and existing health centers, including its membership who operate in excess of 450 sites, through a cooperative agreement with the Health Resources and Services Administration (HRSA). Through this agreement, IPHCA conducts various statewide/regional T/TA activities to assist potential and existing health centers meet Health Center Program requirements and improve organizational performance.

Through a grant received from the DentaQuest Foundation, IPHCA promotes interprofessional activities among medical and dental programs in Community Health Centers (CHCs), elevates the importance of oral health, develops executive leadership at CHCs to promote optimal oral health, advances Safety Net oral health needs at the state level, and optimizes the management of dental programs to provide sustainable and effective oral health care.
