 Artistic - Produce, Promote and Perform Ballets During The Joffrey Ballet's 2013 - 2014 Season, the company presented five programs: a mixed repertory program, Russian Masters (September 2013, 4 performances), Stanton Welch's La Bayadere (October 2013, 10 performances), Robert Joffrey's The Nutcracker (December 2013, 23 performances), a mixed repertory program, Contemporary Choreographers (February 2014, 10 performances), and Krzysztof Pastor's Romeo & Juliet (April/May 2014, 10 performances). The total attendance for these programs was 91,977. Additional performances in Chicago included the Chicago Dancing Festival (August 2013, 3 performance) and the Spring Gala performance (April 2014, 1 performance). Total attendance at the Spring Gala was 866. The Joffrey Ballet's student matinee series offered The Nutcracker to Chicago Public School students for a discounted ticket rate of \$10. Approximately 5,600 students attended The Nutcracker (December 2013, 3 performances). The Joffrey Ballet toured to 8 cities, presenting The Nutcracker, as well as mixed repertory programs. Approximately 35,998 people attended 19 performances in cities throughout the United States.

 Joffrey Academy Joffrey Academy of Dance, Official School of The Joffrey Ballet, is committed to providing a world-class education built on a foundation of classical ballet to students of all ages, levels and backgrounds who have a desire to dance. With the talents cultivated at the Joffrey Academy, students can pursue careers as professional dancers at companies throughout the world, higher education opportunities in dance, or success in other fields. Through the Joffrey Academy's programs, students develop a diverse set of skills including artistry, creativity, discipline and confidence, among others. In fiscal 2014, 1,320 students participated in the Joffrey Academy's programs. This number excludes adult drop-in classes. The Joffrey Academy and Community Engagement programs provide high-quality, educational training which form future audiences and support for The Joffrey Ballet and build the organization's reputation worldwide.

 Community Engagement The primary goal of The Joffrey Ballet's Community Engagement programs is to provide students in all grade levels with a highly structured dance experience where they will develop life skills articulated by Illinois State Board of Education's social emotional learning (SEL) standards such as self-discipline, respect, and confidence through the study of various forms of dance. In addition, these programs help build a strong dance foundation by focusing on correct posture, placement, coordination, strength, flexibility and musicality. By providing this service to disadvantaged youth, we hope to increase the level of awareness of this art form, and instill life skills that last long after programs end. In fiscal 2014, 2,462 students benefited from The Joffrey Ballet's Community Engagement programs.
