The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. At June 30, 2014 there were no unrecognized tax benefits identified or recorded as liabilities. The Foundation files Forms 990 and 990-T in the U.S. federal jurisdiction and the State of Illinois. With few exceptions, the Foundation is generally no longer subject to examination by the Internal Revenue Service for years before 2011.
