Partner agencies submit reports detailing how many clients were provided assistance or units of service that were performed during the grant cycle. They substantiate what services were given and that they were in line with the uses of the grant. Volunteers review these reports to verify the funds were being used for the intended purposes and the outcomes are enough to justify the grants. Volunteers and staff also do site visits to see the programs in action. HOIUW staff conducts yearly audits of the programs at each location to verify data is accurately being recorded and reported.
