Mid Central Community Action provides community education, prevention workshops, and professional trainings provided by domestic violence advocates.

Housing lines of business include homeownership promotion (home buyer education, downpayment assistance), homeownership preservation (mortgage default counseling), multi-family and single family transitional housing rentals. Financial counseling/coaching services include credit building and repair, debt reduction and savings plans. Mid Central Community Action is a collaborative partner in Next Step to provide bundled services to help people become financially secure.
