As part of this process, the President's compensation is compared to a cohort of similar institutions, the Great Lakes College Association. The result of the deliberations and decisions are documented in a statement of salary letter sent to the President and the Director of Human Resources.
Schedule J, Part I, Line 4	A nonqualified retirement plan was created by the College during the fiscal year and the College agreed to fund the plan for President Wilson-Oyolaran. The College funded the plan on July 1, 2014 in the amount of \$71,817. Included in this amount was \$39,099 which represented an overpayment of previous years' contributions into the President's 403(b) retirement plan. This amount had been removed from the President's 403(b) retirement account during the year in order to preserve the qualified tax status of the College's retirement plan.
