Each year, following a specific formula, the Pine Rest Foundation awards grants to Pine Rest Christian Mental Health Services to fund vanous aspects of behavioral health care and counseling programs An award of \$497,870 was made to provide funds for financial assistance for patients with the inability to pay for services An additional \$462,130 was made available for education, prevention, and support programs through the Hospital Funding was provided for the development of a Residency Program, specifically the Residency Program Director and other staff who spent time recruiting, interviewing and selecting the first class of residents Funding was also provided to administer a pre-admission survey for new long-term residents, this survey allowed staff to have ready a welcoming bag filled with the patients favorite items A welcoming party was funded as well as a discharge gift for patients able to move on in their lives Funding was also provided to implement specific evidence based practice models to enhance service delivery, especially focusing on individualizing treatment plans for patients
