Education

We provided two sections of Family to Family classes for family members involving 20 persons. Direct expenses were \$173.

We received copying donation from Community Mental Health Clinton Eaton Ingham. We had indirect costs of a new computer and dues for leadership from our National and state organization of \$1850

This year we had a Mental Illness Awareness Week Event with a speaker giving us an opportunity to involve and educate many members of the community. Direct expenses were \$5,767. We had indirect costs of computer of \$500. We had broad support from the community including the Michigan State University Alumni Group and media coverage. We also had a followup program to explore what could be done in various areas to improve services cost of \$846.

We had 300 people attend and our publicity involved many community groups.

We provided other public education to various groups including a police department. We involved persons with mental illness using our In Our Own Voice Program. Direct costs were \$789. We provide an electronic newsletter as well as a printed copy cost \$592

SUPPORT

We provided social activities including going to a statewide NAMIWALKS, a picnic, and a winter party. Direct costs were \$949.

Indirect costs included cost of new computer \$200.

We provided support group for both persons with mental illness-NAMiConnection and family support group for a direct cost of \$185 and indirect cost of \$700 for dues to National. All total we have approximately 200 people who have participated over the year.

We also provided an exercise program at the YMCA named Hearts and Minds which we gave grants of \$4,992. We had indirect costs of \$100. We had 25 persons participate. We provided a grant of \$200 to a local group for holiday dinners for persons with mental illness. We provide support to persons seeking assistance on our telephone with a cost of \$758.

We also provided support for one person with mental illness and one family member to attend the National conference bringing back information for the group and community at a cost of \$1792.
