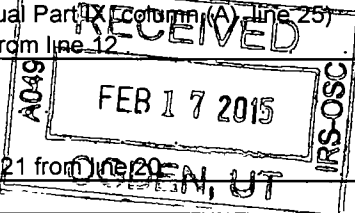

Foundation was separated from the Hospital System. Under previous by-laws, Bell Foundation was

a non-profit organization under the umbrella of Superior Healthcare Systems that operated with

an advisory board for hospital fundraising. Under the new iteration, Bell Foundation undertook

a new name, location, governance structure, mission and vision. In conjunction with Clark Hill

P L C, Bell Foundation filed new Articles of Incorporation and Bylaws with the State of

Michigan, which were subsequently accepted. The foundation's EIN number and tax exempt status

transferred with the new version of the foundation. Only minor changes have been made to the

by-laws since August 2013, with the newest version approved in January 2014.
