WVCAN's professional development programs impact a wide variety of professionals in the child protection system. This year, WVCAN hosted forensic interview peer reviews, a mentoring program, an annual conference and an advocacy training series in addition to providing several other training offerings on a customized basis for different professional groups. WVCAN is in its fourth year of a mental health initiative focused on bringing trauma-specific evidence-based care to child abuse victims. This year WVCAN concluded one round of trauma-focused cognitive behavioral therapy training for 50 therapists and started another year-long TF-CBT training series with another group of 50 providers. In addition, WVCAN works in collaboration with other groups in the state to increase knowledge about childhood trauma, its impacts, and the importance of evidence-based services for the victims. WVCAN supports professionals who do this challenging work. WVCAN provides assistance to new or expanding Centers, oversight and a host of benefits for existing CACs such as access to additional resources.
