The funds support faculty fees, travel, expenses, audio-visual service, recital hall rental, production and reception expenses for the YPCA program in New York City. The William Dawson Education Endowment funds an annual research program and a summer fellowship residency at APAP for graduate students at the Bolz Center for Arts Administration, University of Wisconsin - Madison. The program identifies an issue or topic of importance to the presenting field, a team of students conducts research on that topic, and students present their findings in a summary report to APAP, the findings of which are integrated with organizational strategic planning and shared with the field. The Endowment funds provide stipends and travel support for students to conduct and present their research.
