Support is provided to Saint Michael's Hospital of Stevens Point, Inc ("the Hospital") (39-0808443) to enhance its mission as a Catholic hospital Foundation funds enabled Ministry Dental Clinic (a division of the Hospital which provides dental care to those who otherwise could not afford it) to cover operational expenses Funds were granted to the Medication Assistance Program which aids patients who cannot afford needed medications In addition, the Foundation supported the Hospital's annual Community Weight Race, which provides the community incentives for obtaining a healthy weight The Foundation also supported many other initiatives including Hospital support groups, blankets, wigs, and hats for cancer patients, sleep sacks and books for newborn babies, digital scales for heart patients and a new keyboard for the Hospital chapel
