To serve our mission, we celebrate marketplace role models through our Torch Awards for Ethics ceremony. Annually, we recognize companies who display an outstanding level of ethics and integrity in all aspects of their operations. A key resource we provide businesses is www.bbbethicsshowcase.org. This tool is an ever-growing gallery of business ethics materials (including ethics training videos and ethics policies). Recognizing that our marketplace has both positive and negative influences, we have a very active Center for Fraud Prevention. We provide fraud prevention education to at-risk consumer populations, specifically senior citizens (through 97 presentations and informational fairs) and the military community (giving 58 presentations and informational fairs). We also offer our community-free Secure Your ID shredding events (16 events in our service area recycling over 52 tons of sensitive materials). Our fraud prevention initiatives include our long-standing partnership with law enforcement representatives in both Minnesota and North Dakota (known as the Coalition Against Marketplace Fraud). With over \$31,000 in grants this year, we were able to produce and distribute a fraud education video to senior citizens across our state, teach business leaders about investment fraud, teach students about how to protect their savings from scam artists and more! Finally, we maximize our reach through strategic alliances to save time and ensure stewardship of our resources. This year, we worked with Junior Achievement of the Upper Midwest, the Consumer Federation of America, AARP, and 44 other partners to promote ethics and scam prevention messages.
