Marshall Area Christian School served 118 students in grades preschool through 8th grade. There were 175 contact days of school for grades kindergarten through 8th grade held during the school year. In addition to the academic curriculum for education, MACS provided students opportunities to minister and serve in the community, Fine Arts February which included extra learning opportunities in a variety of fine arts areas, a dinner theater written, performed and produced by the 7th and 8th grade classes, a spring musical performed by the kindergarten through 6th grade classes, and multiple learning opportunities through multiple field trip events. MACS also provided after-school learning opportunities through sports, including flag football, volleyball, basketball and cheerleading. Additional after-school educational programs included science club, knowledge bowl team and speech team activities. A lunch program was provided to students on three days per week with a focus on nutrition through organic foods and local produce, meat and dairy products purchased directly from farmers as much as possible.

Marshall Area Christian School offers a tuition assistance opportunity for all families of students enrolled in grades kindergarten through 8th grade. Tuition assistance is limited to 50% of tuition for all families, except families of teachers with students enrolled at MACS. For MACS teachers, there is no limit on the tuition assistance they may be granted. Tuition assistance is determined by an application made by families to an independent company. This company analyzes each families' income, expenses, assets and liabilities and determines the amount of tuition assistance each family qualifies. This company communicates the amount of assistance to Marshall Area Christian School. To apply for assistance, the family must have paid the non-refundable registration fee to MACS as well as the application fee to the independent company. In the school year 2013/2014 assistance was provided to 18 families providing for a total of 28 students.

During the year we provide opportunities for the students and their families to reach out to serve others. In that endeavor, offerings were given to MACS on behalf of other ministries.

These funds were paid out to both local food shelters and international missions.

Part V #6b - In March, 2014, we conducted a fundraiser - Promise Banquet. At this banquet, a meal and a speaker are provided for those in attendance. In accordance with IRS regulations, the value of the meal and entertainment are listed on the receipts sent out to donors who contribute to MACS the night of the banquet. Notification that donations received the night of the banquet may not be fully tax deductible is included on the Promise invitation sent out prior to the event as well as the pledge card distributed at the banquet for donors to complete.

A school board member is employed as the part-time music teacher. When issues arise related to these areas, the individual school board members abstain from voting.

Part VI #6 & 7 The parents of all enrolled students as well as all employees are considered members. Members vote to elect by majority vote the members to serve on the school board.

Part VI #11b - The Form 990, Schedules and financial statements are given to the school board members for their review and approval. At a school board meeting all questions and concerns are addressed. Upon approval by the school board, the Form 990 and required Schedules are submitted to the IRS.

Part VI #12c - Each year the school board members are asked to disclose any potential conflicts of interest. Additionally, if there is a conflict for a board member regarding a specific issue, they abstain from voting. Monitoring and compliance are handled appropriately for each occurrence within the school board meetings.

Part VI #15 - No officers or school board members receive compensation for their service on the board. The part-time administrator's salary is determined by the school board as a part of the normal payroll process.
