The Arts Activities Support program offers grants of up to \$10,000 in project support for groups wishing to offer quality arts activities in any discipline within the seven-county metro area Grant requests may include costs for artists and other personnel, postage, supplies, equipment, printing, travel and other expenses necessary to carry out the project In FY2014, MRAC received 243 applications requesting \$2,309,834, and awarded 141 grants totaling \$1,367,484 in this program The Community Arts grant program provides grants of up to \$5,000 in project support for metro groups wishing to offer quality arts activities in any discipline to communities within the seven-county metropolitan area The program utilizes a block grant system to distribute funds Each of the counties in MRAC's service area Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington receives a block of funds designated for arts activities occurring within that county Community Arts is intended for community based and volunteer groups, smaller, established arts groups, and newly formed groups or first-time initiatives Grant requests may include costs for artists and other personnel, postage, supplies, equipment, printing, travel and other expenses necessary to carry out the project In FY2014, MRAC received 180 applications requesting \$857,732, and awarded 131 grants totaling \$620,455 in this program The Arts Learning program provides grants of up to \$10,000 for high-quality, age-appropriate arts education for Minnesotans of all ages to develop knowledge, skills, and understanding of the arts MRAC's goals for the Arts Learning Program are to cultivate creativity and deepen knowledge of and/or through the arts for children, youth and adults by engaging people in extended arts experiences and activities with clearly articulated learning objectives In FY2014, MRAC received 133 applications requesting \$1,119,021, and awarded 52 grants totaling \$489,873 in this program The Organizational Development program offers grants of up to \$10,000 for projects designed to strengthen the management or administration of nonprofit arts groups Such projects must 1) advance the mission of the group and 2) have the potential for significant or long-term impact In FY2014, MRAC received 40 applications requesting \$355,776, and awarded 24 grants totaling \$216,830 in this program The Capital grant program provides funds of up to \$10,000 to purchase equipment and related supplies and services, or to make capital improvements Such activities must 1) advance the mission of the group and 2) have the potential for significant or long-term impact In FY2014, MRAC received 37 applications requesting \$316,552, and awarded 24 grants totaling \$207,832 in this program The ADA Access Improvement Fund is operated in partnership with VSA Minnesota, a nonprofit organization specializing in arts programs and services for people with disabilities The program provides grants of up to \$15,000 for arts organizations to increase accessibility to consumers and participants in their activities In FY2014, MRAC paid VSA Minnesota a grant of \$220,000 for administration and grants for this program In addition, MRAC awarded one grant of \$300 through its Emergency Accessibility program directly to one organization to meet unforeseen audience accessibility needs The Management Consulting Fund program offers grants of up to \$1,500 to provide consultants for groups to complete small projects to strengthen the management or administration of the group Such management consulting projects must 1) strengthen the management or administration of nonprofit arts groups, 2) advance the mission of the group, and 3) have the potential for significant or long-term impact The Management Training Fund program offers grants of up to \$600 to provide training funds for the staff and volunteers of nonprofit arts groups to attend management workshops, seminars or conferences In FY2014, MRAC received 118 applications requesting \$105,253 and awarded 78 grants totaling \$53,578 in these two programs The Next Step Fund is MRACs grant program for individual artists, providing grants up to \$5,000 to professional artists in any discipline for the purpose of career development and artistic achievement The Next Step Fund is funded entirely by the McKnight Foundation In FY2014, MRAC received 348 applications requesting \$1,678,178 and awarded 38 grants totaling \$182,586 in this program

MRAC also provides skill-building trainings and workshops for administrators of small arts organizations at no charge to participants in areas such as marketing, finance, fund-raising, and governance In FY2014, MRAC provided 23 such workshops for approximately 570 participants
