THE FLORENCE ACADEMY OF ART WAS FOUNDED IN 1991 BY DANIEL GRAVES TO PROVIDE THE HIGHEST LEVEL OF INSTRUCTION IN CLASSICAL DRAWING, PAINTING AND SCULPTURE. GRAVES' VISION OF THE ACADEMY IS ITS POTENTIAL TO TRAIN A SELECT GROUP OF HIGHLY SKILLED REALIST PAINTERS AND SCULPTORS. HIS PHILOSOPHY, WHICH UNDERLIES THE ACADEMY'S CURRICULUM AND METHOD OF INSTRUCTION, DEMANDS A RETURN TO DISCIPLINE IN ART, TO CANONS OF BEAUTY, AND TO THE DIRECT STUDY OF NATURE AND THE OLD MASTERS AS THE FOUNDATION FOR GREAT PAINTING AND SCULPTURE. UNDER HIS DIRECTION, THE ACADEMY IS A SOURCE OF STIMULATION AND HEALTHY COMPETITION, IN WHICH AN INTERNATIONALLY VARIED GROUP OF STUDENTS RECEIVES TRAINING FROM PROFESSIONAL PAINTERS OF DIFFERENT NATIONALITIES, IN A CITY RENOWNED FOR ITS ARTISTIC PAST.

		Daniel Graves began the Academy in 1991 in a small studio in the gardens of a local Florentine palace. By word of mouth, the handful of students who had come to study with Graves grew to exceed the space available. In 1994, the Academy moved to a single 4500 square-foot studio housing two disciplines (drawing and painting), the first student body consisted of 16 students taught by three instructors (Daniel Graves and 2 assistants) with one administrative staff (Susan Tintoni). It has since grown to six studio locations in two countries, 18 principle instructors, 8 assistant instructors and 6 administrative staff (4 are part-time), offering instruction and service to 127 full-time students from 35 countries and over 150 continuing education students per year. During its 21-year period, the Academy developed several important year-long programs: Anatomy (required of all first year students) and Ecorch Sculpture, Art History, and Composition, as well as optional part-time courses including evening sculpture class for painters, and Landscape painting conducted during Fall and Spring trimesters. Enrollment for the academic year program rose from 16 students in 1994 to 127 in 2013. Students study on a full time basis only, 36 hours per week, from October through June, preference is given to applicants who intend to stay the full three years, a fourth year of specialization is the norm. Applications for academic year study exceed available spaces 3 to 1. Equally successful is the continuing education programming with enrollment in most courses reaching 100%. The Academy counts 246 graduates of its painting and sculpture programs, of these, 70% are pursuing careers as professional artists. Each year, this number grows by at least twenty new graduates who complete the three-year curriculum and enter the art market. Their work is featured in the Alumni Gallery on the Academy's website, www.florenceacademyofart.com, and in the 40 galleries linked to the site. The program directors and principle instructors are graduates of the Academy's three-year program. The assistants are enrolled in their second or third year, they are selected based on talent and communication skills, and receive tuition scholarships. Their presence guarantees a continuum of the Academy's philosophy and artistic language. Most of our instructors work in one of the Academy's studios, students therefore benefit not only from daily direct instruction and critique, but also from watching the artist at work. Financial aid: Work-study in the form of partial or full tuition scholarships to students amounted to \$ 164,000 in 2012/2013, and was subsidized by regular tuition income (75%), and Board contributions or private donations (25%). Normally reserved for students in their second or third year of study at the Academy, on a few occasions, financial aid may be offered to first year students who display significant talent and a high degree of motivation in their chosen field of study. The Academy was approved by the International Education Finance Corporation that provided low interest loans to U.S. and Canadian students until April 2008 when all funding was terminated. The Academy's main source of scholarship funding is the Named Scholarship Drive. Sponsors are matched to one or more students, and participate in their progress for all or part of their program of study. A sponsor will know the name of the person he is helping, follow his or her career through quarterly updates from our office, and be remembered at the end of each school year with a gift of artwork by the student he has helped. He may choose to remain anonymous, or get to know the student from the start, and may personally award the scholarship at our graduation ceremony in Florence in the Spring. The Academy acquired for its lending library 600 volumes, and its Art History staff collected over 7000 images for the image archive, it also acquired membership in ArtStore, an on-line database of over 500,000 images operated by the Mellon Foundation. This is made available to students via the library computer and on-line through the Florence Academy Blog. Throughout the years the Academy has purchased or received as gifts from students a collection of drawings, paintings and sculpture numbering close to 100 works. These remain on view to students and visitors in the Academy's student gallery located in the main studio, and the corridors of the various studios. These works serve not only as examples of exceptional student work to admire but for study. In addition, the Academy owns four 19th century figure drawings, and received in donation from Edward T. Wilson two original drawings by Jon Leon Grome and Charles Bargue. The Florence Academy of Art is accredited by the National Association of Schools of Art and Design (NASAD) as a U.S. certificate program in Painting and Sculpture. Goals: Long-term: the principle long-term goal is to acquire a building in Florence large enough to house all three programs, Medium term goals: regular "Visiting Artists Lecture Program" in Florence. Short-term goals: scholarship funding and acquisition of didactic material (books, slides, 19th century drawings, student work.)
