 Provided emergency shelter and supportive services for 103 homeless families and 336 individuals. 74% of the families served by New Directions Shelter moved into more permanent housing; 38% increased their household income by 10% or more; 73% of the adults that looked for employment gained employment; and 87% of the families that needed childcare service obtained free or reduced cost childcare.

 Provided supportive housing and supportive services for 30 families including 126 individuals. 100% of the families moved into permanent rental housing when they left the program. Families that completed the program increased their monthly household income by 145%. 100% of the adults in the program were either employed, in job training, or attending school.

 Through a collaboration with United Way of Central Iowa, served as employer of record for the workforce strategist position. The position was responsible for providing support to the Central Iowa Works collaborative which provides job training/education and employment opportunities for low income and under-employed individuals.
