VCSS delivers services from locations throughout California. Funding is provided by County Departments of Behavioral Health, Social Services and Probation. Additionally, VCSS contracts with local school districts, Special Education Local Planning Areas (SELPA's), the State Department of Rehabilitation and private health insurance companies.
