	Junior Achievement of Middle America, Inc. reached 17,048 students in the Kansas City metropolitan area and St. Joseph, Missouri area through 810 classes taught by 673 volunteers throughout the 2013-14 school year. Engaging themes help K-5 students learn economic concepts through the Elementary School Program. Each theme builds on the previous and stresses the relationship between school and future success. The Middle Grades Program emphasizes the importance of an education and staying in school while introducing students to economic concepts and information about the world of work, financial literacy, and entrepreneurship. The High School Program strives to help students develop the knowledge, skills, and attitudes necessary to become productive citizens and workers. Through these classes, students received 97,830 contact hours of instruction that meets the common core educational standards recognized in Kansas and Missouri. Additionally, 31 companies participated in the annual Bowl-a-Thon event with a total of 943 bowlers raising over \$190,000 for Junior Achievement. Local businesses also provided in-kind services totaling \$78,430.
