Service Objective Awards - The organization awards grants to community organizations in support of the organization's mission which seeks to improve the lives of women and girls in greater Kansas City. Soroptimist Kansas City Foundation has awarded a total of \$931,637 in grants from 1954-2014. Virginia Porth was a member of the Soroptimist Kansas City Foundation who worked passionately to increase educational opportunities for women. After her death, Soroptimist established an award in her name to assist women in reaching their educational goals. In 2008, a named graduate fellowship was established at the University of Missouri - Kansas City to assist a female student in the health field. In fiscal year 2014 \$2,000 was awarded to the UMKC Women's Council Graduate Assistance Fund.

Recognition Programs - Soroptimist Kansas City Foundation participates in the three recognition programs: Women's Opportunity Awards - Aiding female heads of household seeking to expand their opportunities through education. These awards assist them in overcoming barriers by providing opportunities for training, re-training, and college education. We give two annual Women's Opportunity Awards to women who are head of household and enrolled in school while working to support their families. The cash awards of \$1,500 for first place and \$1,000 for second place may be spent in any way the winner chooses and are intended to recognize the women's strength and determination. Winners are chosen from among the applicants by judges from the local community. Violet Richardson Awards - These awards recognize young women ages 14-17 for their exceptional volunteer excellence. The Violet Richardson Awards are named after the first president of Soroptimist in 1921. The award honors young women between the ages of 14 and 17 for their volunteer efforts. Our club gives out three annual awards: first place \$700, second place \$500, and third place \$300. Judges from the local community choose finalists from among all applicants and interview them to select the winners. Ruby Award - The Soroptimist Ruby Award. For Women Helping Women recognizes and honors the first federation president, Ruby Lee Minar. A ruby is also a deep red gemstone associated with wisdom, importance, vitality, strength, vivacity, power and love - all words embodying the strong and compassionate women who are our award recipients. The Soroptimist Ruby Award honors women who have worked to improve the lives of women and girls through their professional and/or volunteer work. A Ruby Award was not granted this year. These awards also assist women in overcoming barriers by providing opportunities in training, re-training and college education.
