Circle of Nations is a residential school serving American Indian youth in grades 4 through 8. In 2013 - 2014 there were 131 students who attended the school. The purpose of the Circle of Nations residential educational program is to prepare students to learn, and to foster a healthy development of the whole child in a Native American cultural environment. The school's mission and purposes are reflected in the vision statement: "Circle of Nations is the spirit of youth empowered." Circle of Nations School was awarded the Carol M. White Physical Education Program (PEP) August of 2012.
