Arts Alive, Inc. is an art organization based in West Point, VA that serves the mostly rural areas of the counties of King and Queen, King William, and New Kent as well as the Town of West Point. Arts Alive provides artistic opportunities such as high quality performances, art exhibits by local artists, art workshops, and children's summer camps in drama and the arts at a reasonable cost. Arts Alive's mission is to promote and stimulate an awareness and love of the arts. Arts Alive intends to achieve this goal by instituting, funding, supporting and administering arts programs.

During the 2013-2014 season, Arts Alive, Inc. presented 5 season performances, 8 adult art workshops, 2 after school children's art classes and 5 art exhibitions. 312 patrons were subscribers in the current 2013-2014 Season.

The Visual Arts Committee plans an art exhibit and art opening to coincide with each performance in the season series. The Visual Arts Committee also plans adult and student workshops for each year. Arts Alive is committed to providing inexpensive opportunities in the arts, and the workshops are only \$15 each, with very few requiring additional funds for supplies. These workshops are taught by Virginia Museum of Fine Arts educators as well as local artists.

Arts Alive offers two weeklong summer camps for area children. The Summer Arts Camp has been offered since 2007, and this year 125 campers took 43 classes taught by 13 teachers. Classes at the Summer Arts Camp include visual arts, dance, music, drama, computers, and photography. The paid teachers for this camp are art professional and teachers from the Arts Alive service areas of the counties of New Kent, King William, King and Queen, and the Town of West Point. The last day of camp, an open house is held. All visual arts classes display their work in the exhibit area outside the auditorium, and performing arts classes showcase what they have learned during the week in short performances in the auditorium.

Since 2006, the Missoula Children's Theatre Drama Camp has been held and staffed by two Missoula actors as well as Arts Alive's coordinator and volunteers. The drama camp is run as a day camp each year. In August, 2013, Arts Alive offered workshops in cooking, art projects, dance and drumming. 57 area children participated in presenting two performances of *Jack and the Beanstalk* to 350 patrons.

Arts Alive, Inc. is staffed with a part-time Coordinator and is governed by a 15 member Board of Directors who meets on a monthly basis and is supported by an Arts Council comprised of members from each of the municipalities it serves through the following committees: finance, marketing, presenters, technology and visual arts.
