NOTE 1 - NATURE OF ORGANIZATION

The GCE Foundation (Foundation), an Illinois non-profit corporation, promotes experimental learning in education by (i) providing scholarships and student-support services to low-income high school students and their instructors, (ii) creating a community network of individuals, corporate, and non-profit organizations who support experimental learning, and (iii) supporting a parent association for GCE Lab School

On October 1, 2012, the members of Global Citizenship Experience, LLC (GCE LLC), contributed their membership interests in GCE LLC to the Foundation. Effective as of that date, the Foundation began operating the Global Citizenship Experience Lab School (School), a private high school in Chicago, Illinois, which consisted of approximately 42 students during the 2013/2014 school year.

Effective June 30, 2014 the Foundation transferred its membership interest in Global Citizenship Experience, LLC (GCE LLC), including certain trademarks and service marks, to Global Learning Models, LLC (GLM), a Delaware limited liability company. In addition, GLM forgave debt owed under notes payable in the amount of \$490,000.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Principles of Consolidation - The consolidated financial statements include the accounts of GCE Foundation and its wholly-owned subsidiary, GCE LLC. All significant intercompany accounts and transactions have been eliminated.

Basis of Presentation - Financial statement presentation follows the recommendations of the Financial Accounting Standards Board (FASB). The Foundation is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. The Foundation has no permanently restricted net assets.

Restricted and Unrestricted Revenue and Support - Contributions and grants received are recorded as unrestricted or temporarily restricted support depending on the existence and/or nature of any donor restrictions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Support that is restricted by the donor is reported as an increase in unrestricted net assets if the restriction expires or is met in the reporting period in which the support is recognized. All other donor restricted support is reported as an increase in temporarily restricted net assets. When a donor restriction expires, (that is, when a stipulated time restriction ends or purpose restriction is accomplished), temporarily restricted net assets are reclassified to unrestricted net assets and reported in the Statement of Activities as net assets released from restrictions.

Tuition is charged to students upon enrollment and is adjusted based on scholarships received or other factors. Tuition is recognized as income evenly over the school year.

Accounts Receivable and Allowance for Doubtful Accounts - Receivables consist primarily of tuition and amount due for fees. Each year tuition and fee rates are established and are reduced by any discounts and/or tuition support awarded to each family. Due dates are determined by the payment option agreed upon between the Principal of the school and the enrollee. Collection efforts on delinquent accounts begin once overdue payments extend past the school year for which the overdue balance applies.

The carrying amount of receivables is reduced by an allowance for doubtful accounts that reflects management's estimate of the amounts that will not be collected. There was no allowance for doubtful accounts as of June 30, 2014.

Unearned Revenue - Unearned revenue represents deposits received for registration and tuition for students who have enrolled in the School for the subsequent school year.

In-Kind Contributions and Donated Services - In-kind contributions consist of donated supplies and professional services. The Foundation has requested providers to submit documentation in support of their contributions. The value of in-kind contributions is reflected in the consolidated financial statements to the extent that the providers of the contributions submit proper support to quantify the donations' value. These contributions have been presented in the consolidated financial statements as support with a like amount shown as subcontractor fees.

Functional Allocation of Expenses - The costs of providing the various programs and other activities of the Foundation have been summarized on a functional basis in the accompanying consolidated financial statements. Accordingly, certain expenses have been allocated among the programs and supporting services benefited.

Advertising - The Foundation expenses advertising as incurred Advertising expense was \$1,237 for the year ended June 30, 2014

Income Taxes - The Foundation is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code GCE LLC is a limited liability company and all tax attributes flow through to the Foundation However, exempt organizations may be subject to income tax on any unrelated business income At June 30, 2014, no provision or liability for income taxes has been recorded

The Foundation evaluates tax positions taken in the course of preparing its tax returns to determine whether tax positions are "more-likely-than-not" of being sustained by the applicable tax authority Tax benefits of positions not deemed to meet the more-likely-than-not threshold would be recorded as a tax expense in the current year

Estimates and Assumptions - The presentation of consolidated financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period Actual results could differ from those estimates

NOTE 3 - CONCENTRATION OF CREDIT RISK

The Foundation and GCE LLC maintain their cash in bank deposit accounts, which do not exceed the FDIC limits The Foundation and GCE LLC have not experienced any losses in such accounts The Foundation and GCE LLC believe they are not exposed to any significant credit risk on cash

NOTE 4 - NOTES PAYABLE

\$390,000 unsecured note payable to a related party which bears interest annually at 1% with a maturity date of June 1, 2018 On June 30, 2014, the note was cancelled by the related party, which created a gain on forgiveness of debt of \$390,000

\$100,000 unsecured note payable which bears interest annually at 5% with a maturity date of April 12, 2018 On June 30, 2014, the note was cancelled by the related party, which created a gain on forgiveness of debt of \$100,000

NOTE 5 - LEASE COMMITMENTS

The Foundation leases its premises under an operating lease expiring on August 31, 2015. The lease provides for minimum rent plus the Foundation's allocable share of utilities. Rent expense for the year ended June 30, 2014 was \$62,181. As of June 30, 2014, there will not be a future obligation on this lease to the Foundation, since it was transferred to GLM.

NOTE 6 - INCOME TAXES

The Foundation files its exempt organization income tax returns in the U.S. Federal jurisdiction and the state of Illinois. The Foundation is no longer subject to income tax examinations by taxing authorities for years prior to 2012.

NOTE 7 - SUPPLEMENTAL CASH FLOW INFORMATION

No interest was paid during the year.
