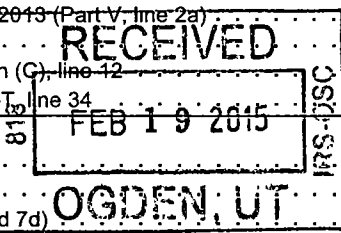

In March, 2012, BSCD Properties, Inc. received donations of five (5) single-family residential properties from two not-for-profit organizations. Beginning in April 2012 BSCD Properties provided the residential properties to DeKalb Community Service Board as residences for developmental-disabled clients. The monthly rental terms for the properties remained the same as had been contracted between DeKalb CSB and the donor entities. DeKalb CSB provided programs and services to the developmentally disabled adults. The agency operates day programs that offer work activities, dat rehabilitation, physical therapy and community access activities. The agency also operates a residential program for its clients. BSCD maintains and operates the residential homes in support of the DeKalb CSB programs.
