THE EMERGENT HEALTH PARTNERS CENTER FOR EMS EDUCATION OFFERS ALL EMS LICENSURE LEVELS AVAILABLE THROUGH THE STATE OF MICHIGAN, MEDICAL FIRST RESPONDER (MFR), EMERGENCY MEDICAL TECHNICIAN - BASIC (EMT-B), EMERGENCY MEDICAL TECHNICIAN - INTERMEDIATE (EMT-I), EMERGENCY MEDICAL TECHNICIAN - PARAMEDIC (EMT-P), AND EMS INSTRUCTOR COORDINATOR (IC).
