Holy Trinity Classical Christian School, Inc. filed Form 1128 with the IRS on 11/11/14 requesting a change in tax year end from May 31 to June 30. On November 24, 2014, the IRS approved the change in tax year to June 30 (a copy of the IRS approval is attached to this return). Holy Trinity filed Form 990 for the tax year 6/1/13 through 5/31/14. This filing is for the short year of 6/1/14 through 6/30/14. Holy Trinity completed its second school year on 6/6/14 operating a PreK through 6th grade classical Christian program for 53 students in preschool and 97 students in grammar school. Most of the revenue and expenses for that school year were included in the 5/31/14 Form 990. Minor fee income and our normal operating expenses for the month of June, predominantly salary and related for our staff and facility related costs are reflected in this short period filing.
