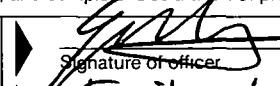

The CSW Network designs, plans, and conducts professional development opportunities for educators employed at member Community Science Workshop (CSW) Sites. Training topics include science concepts and curricula, workplace safety and sexual harassment, pedagogy and best practices, and special exhibit orientations. In order to maximize the accessibility of these trainings, and therefore their positive impact on programs for youth, the CSW Network pays travel expenses, meals, and offers stipends for participating educators from member CSW sites. The CSW Network also makes it possible for CSW educators to attend events and conferences relevant to the field of informal science education, where CSW educators report that they encounter many new ideas and helpful tools to bring back to their own programs serving youth. This year we brought 15 educators and 25 youth from four participating member CSW sites across the state to the annual MakerFaire in San Mateo, as well as supporting trainings on electricity and gray whale anatomy at several of our member CSW sites, and complete Sexual Harassment prevention and education trainings for educators at sites in Watsonville and Sanger which otherwise wouldn't have access to those trainings

Technical Assistance to member Community Science Workshop sites in the CSW Network was one of our biggest programs in Fiscal Year 2014. CSW Network personnel, including the Executive Director, provided in-person Technical Assistance to member CSW sites in a variety of areas, including budgeting and accounts management, fundraising and grant writing (funds to be raised for independent member CSW sites through their own entity, and not for the CSW Network); public relations and marketing, facilities design and remodel, and representation in negotiations with local partners. This Technical Assistance program was vital to many of our member CSW Site's survival and continued growth this year, and represented a significant proportion of effort of our paid staff. The expenses of this program included CSW Network staff time, as well as travel costs for sending staff to visit member CSW sites in need around the state

The CSW Network directly supports programs for youth at member CSW sites, by providing grants to these organizations and by purchasing equipment for use in the programming. This year, we purchased a digital microscope for our Sanger Community Science Workshop, and the balance of our Direct Support funding was distributed as grants to our member CSW sites, funding programs serving youth in the community in Sanger and at the Mission Science Workshop in San Francisco

Part II, Line 10 Our organization categorized reimbursement income as a form of income this fiscal year, for which we received a total of \$2,033. These funds were reimbursed to our organization to cover travel and registration costs to various events for which our participation was funded by the organizations putting on the events.

Part II, Line 17b The CSW Network maintains a continuous program for solicitation of funds from the general public, community, governmental units, and private foundations, through an active grant writing program. In addition to the many proposals we submit to private foundations and governmental units each year, we solicit donations from the public at all our public events, and CSW Network staff seek out, initiate, and coordinate partnerships with other organizations that result in sub-awards to the CSW Network from grants written by our partner institutions. We received significant financial support from four private foundations, and small cash donations from more than 50 individual donors, during the past fiscal year. Our governing body represents a broad sector of the community. CSW Program Directors, volunteers, and professors from science departments at San Francisco State University, University of California Berkeley, and Fresno State University. The majority of services provided by our Network are directed at strengthening and supporting our member CSW Sites, each of which offers free, hands-on science education to schools and to members of the public on a drop-in basis. Therefore, when we train CSW educators in a new science concept, or when we fund drop-in hours at a member CSW site, we are directly benefiting the public by ensuring that low-income and historically underserved youth have access to the best in innovative, hands-on science education, right in their own neighborhoods and schools. In addition, the CSW Network hosts an online database of science projects and activities which is available to any member of the public free of charge, and is used by educators and parents across the country.

Each Grant Agreement details the way the funds will be used, the timeline of grant performance, and the reporting requirements, as well as a stipulation that the funds will only be used for the purposes stated in the activity description. We typically require a mid-term and end-of-term grant report for grants with an award period of more than a year, and an end-of-term grant report for grants with an award period of a year or less. These reports must include detailed descriptions of how funds were spent, including financial documentation, as well as data on the impact of the work conducted under the grant, youth served, schools reached, etc. These reports are kept archived, and are referenced when future proposals are submitted by the same organization, to ensure a record of compliance with grant terms.

2013. As such, all activities of the CSW Network in prior fiscal years, and through December 2013 in this fiscal year, are reported on

Community Initiative's returns. This is the first year we are including our own activities on our form 990 (see Section III, Line 4).

Part III, Line 4d Other CSW Network activities included coordination of Network-wide projects benefiting member CSW sites, such as our

Curriculum Documentation program, publishing projects and activities on our web database for use by CSW staff and other educators,

Network-wide research projects, including a collaboration with the Exploratorium to document best practices in use at CSW sites and to

develop professional development tools for training staff in those best practices.

Part VI, Line 1b The CSW Network operated as a Type I 509(a)(3) Supporting Organization during the past fiscal year, and as such, the

majority of our Board of Directors was appointed by our Supported Organizations, which are also our member CSW Sites. These seats

were filled by the Site Directors of the Supported Organizations, and constituted five of the nine total seats, leaving only four seats that

qualify as independent.

Part VI, Line 4 The organization changed our Articles of Incorporation in November of 2013. Our original Articles listed four of our

Supported Organizations by name. In the summer of 2013, one of these organizations chose to leave the CSW Network and to no longer

be a Supported Organization, so this organization (Oakland Discovery Centers, a program of the City of Oakland) was removed from our

Articles.

Part VI, Line 11b The completed 990 form is sent out to the full Board of Directors for review one working week prior to the filing deadline.

Board members are responsible for reviewing the completed 990 and attached schedules, and notifying the Executive Director of any issues

prior to the filing date.

Part VI, Line 12 Our organization and Board of Directors is quite small, and members know each other well, therefore, we do not have any

kind of automatic system for identifying potential conflicts of interest. Rather, as part of our policy we require Board members to

disclose potential conflicts of interest prior to discussion at meetings, and to recuse themselves from voting on any topic which constitutes

a conflict of interest.

Part VI, Line 15 The compensation of our Executive Director position was raised to \$27/hr (annual salary \$56,160) via a process that

involved discussion and voting by all active Board Members on a private email thread. Board members considered standard compensation

rates in the nonprofit sector in the geographic area of operation, and the discussion and vote was documented in the private email thread.

The final decision was relayed to the Executive Director by the Board Chair.
