Safe Harbor staff can be contacted via telephone 24 hours a day, 7 days a week, 365 days a year The Organization shelters victims and children of domestic violence for a temporary period of time while they are looking for a new, safe place to live The Organization also provides advocacy services for victims of domestic violence, sexual assault, bullying, and stalking In FY2014, Safe Harbor assisted 310 women, children and men that were victims of domestic violence Safe Harbor also assisted 64 stalking victims, 10 sexual abuse victims, 3 adolescent sexual abuse victims, 8 child abuse victims, 38 domestic violence protection orders, and 17 stalking protection orders The Organization sheltered 51 women and 46 children, providing 2,090 bed nights and 6,270 meals
