The organization's primary purpose is to provide marginalized students with scholarships, academic support services and enrichment activities and to promote their academic and professional success.

The organization's program service accomplishments: Scholarships, Work Study, Student Support & Enrichment.

Scholarships:

70 needy students in various communities in Tijuana, Mexico are given economic assistance. This enables them to attend school beyond the 6th grade. Students are required to attend monthly meetings, participate in service projects and maintain good grades.

Work Study:

Students have the opportunity to participate as staff at the community center. Students provide office support and tutor more than 70 children in the neighborhood. Students also plan and staff a 4-week summer camp for 100 children that includes academic, sports and enrichment activities.

Student Support:

Students receive educational supplies, mentoring, opportunities for leadership, community building and parent/student workshops.

Enrichment:

Educational programs include field trips, attendance at conferences, extra-curricular activities.

The mission of Advancing Students Forward (ASF) is to provide disadvantaged students access to education and support for academic success so that they can provide a promising future for themselves and the community in which they live.

ASF serves at least 70 needy students in grades 7 to the university level. Students must demonstrate economic need, provide evidence of good grades and live in the vicinity of the community center in the town of Tecolote in the city of Tijuana, Mexico. Students are required to participate in monthly meetings and perform service projects.

Students are given scholarship money on a monthly basis to help with tuition and educational expenses provided they have fulfilled their monthly requirements and obligations to the program.

Students are supported in a variety of ways at the monthly student meetings, which consist of team building activities and educational presentations to provide academic support and guidance. University level students serve as team leaders and direct the meetings and prepare the educational presentations. Alumni of ASF continue to participate and mentor the current students. They also serve as ambassadors for ASF in the broader community. Parent/student workshops are offered 2-3 times a year to strengthen the child/parent bond, improve their communication and to expand the parent's understanding of the academic challenges and requirements their children face.

Each academic year a specific curriculum is designed to meet the student's needs and to expand their horizons. In 2014 the students participated in basic art lessons in color, light and shading, self-portraits and mural making. They used watercolors, pencil, charcoal and acrylic paints. Art lessons were combined with writing lessons in poetry and self-expression. Each student created 7 original works of art and a team mural. Students visited the art gallery at CEART art center in Tijuana where they participated in art lessons as well. Students with visas attended a tour and art exhibit at the Mingei Museum in Balboa Park in San Diego and created fabric sculptures with visiting artist Steven Ladd. Students also toured the murals at Chicano Park in San Diego. All of the students contributed to a compilation of Tijuana murals by photographing the murals they encounter in their community on a regular basis. The Oscar award winning film, Inocente was viewed at the parent/student meeting, followed by discussion and reflection.

Curriculum presented in past years include: Internet safety, internet etiquette, cyber-bullying, human trafficking, communication between adolescent and parent, public speaking, goal setting, self-respect and sexuality.

Future curriculum, which is in the planning stages, will focus on technology and careers in engineering. This will also include a robotics competition.

Work-study and volunteer activities are also available to the students. Students meet at the Community Center, Centro de Comunidad de Tecolote in Tijuana, Mexico and some students are staff members. Students serve as tutors for the many classes offered to the community including homework support, English and computer classes. The Community Center serves more than 70 elementary students from the neighborhood. Participants of ASF prepare the curriculum and staff the summer program for elementary school children. ASF students are looked upon as role models in the community.

Enrichment activities include field trips to expose the students to the many cultural and educational opportunities in Baja, CA, Mexico. Students have opportunities to attend conferences outside of Tijuana and students with visas participate in cross-cultural events on the U.S.A side of the border including the International Friendship Games in Chula Vista, CA and World Link at University of San Diego.

Each year approximately 10 new students are accepted into the program. In 2014 6 students graduated from middle school, 5 graduated from high school and 3 graduated from university. The university graduates work full time in their field of study. Seven students were accepted into the university for the 2014-2015 school year.

Currently, for the 2014-15 school year, ASF serves 26 students in middle school, 23 in high school, 22 university students and one in technical courses. The majority of students participate in Advancing Students Forward for 6-10 years.
