Clarksville-Montgomery County Arts and Heritage Development Council (AHDC) allocated \$14,888 to seven organizations in four counties through the Tennessee Arts Commission's "Arts Build Communities" grant program. The supported programs reached approximately 47,100 citizens in these counties, according to estimates provided by the grantees. This past year, AHDC hosted a writers conference where published authors from around the Southeast gave workshops, readings, and seminars on writing and publishing to approximately 80 aspiring authors while raising \$11,129 to support its various services. AHDC also recognized arts and heritage community leaders through its annual awards ceremony, produced a cultural calendar highlighting arts and heritage events along with local artwork, organized a Valentine's event to allow local artists to sell their artwork, sponsored a series of six high school art and theatre exhibitions to foster arts education, worked with Clarksville Parks and Recreation to hold the Riverfest Tour d'Art, hosted the Middle Tennessee Watercolor Society's fall exhibit, offered a Heritage Home Tour of Robertson County to 80 Clarksvillians on two buses, and fielded six First Saturday Workshops where participants learned to play a mountain dulcimer, paint a watercolor picture, make metal jewelry, draw caricatures, write a memoir, and recycle ephemera into art.
