The Pollination Project identified and provided seed funding for approximately 365
grassroots social change projects all over the world. Our diverse network of grant
advisors helped us provide funding for a wide range of up and coming social change
leaders in 55 countries and nearly every state in the US. Some of our grantees have
leveraged our seed grant and used it as a launchpad for international awards, major
media attention, and larger government and foundation grants. We funded projects that
promote environmental sustainability, social justice, human rights, arts & culture
and education.

We provided a suite of services to our grantees including grantee networking, media
and p/r support, social media promotion, one on one coaching, and even additional
fundraising support. This support has allowed grantees to make important connections
with others in their field, raise more money, and build additional credibility for
their work.

Our philanthropic education program is the backbone of our ability to share our story
and best practices with others. We produced 3 Pollination Project "salons" which bring
together grantees, philanthropists, and others in the SF Bay Area to learn together
on topics such as "How to Measure Goodness," "Evangelical Organizing," and "Generosity,
Grief and Love". We have reached about 100 people through our salons. We also write
articles and share stories for the philanthropic community via Philanthropy Journal,
Huffington Post and Daily Good, and more.
