You may apply for a food order **ONCE EVERY 28-30 DAYS**. If the 30th day falls on a Friday, a weekend or a holiday, you may come in not more than three days early.

A HOUSEHOLD IS DEFINED as related or unrelated persons living in the same apartment or house. For example, two single people sharing housing will receive food based on a two-person household, not for two people applying separately. If you are picking up food for another person or household (already registered with the Food Bank), please provide a note from that person, plus ID and proof of address.

All information provided to the Augusta Food Bank is subject to verification. If you provide false information you may lose the privilege to receive food assistance. The Augusta Food Bank also reserves the right to require additional documentation when deemed necessary to ensure compliance with our policies or federal or state law.
