Field Services In FY2014, NMSC Field Services staff offered a wide range of training seminars and workshops, all tailored to meet community need and advance historic-preservation based community development. Commonly requested workshops and seminars included a variety of historic preservation and organizational development topics, such as the basics of real estate finance, how to facilitate effective meetings, recruit volunteers, develop a fundraising plan and build an effective membership program (continued on schedule O)

In FY2014, the NMSC focused on delivering excellent benefits and high value services to the NMSC network through its membership program. NMSC provides members with cutting edge resources, training, research and networking opportunities. NMSC membership includes access to a wide range of educational materials, most of which were digitized and made available to members free of charge in FY2014. The NMSC also improved the design and substance of its two major communications offerings for members, the e-newsletter Main Street Weekly, and the quarterly magazine, Main Street Now (continued on schedule O)

In FY2014, the NMSC brought together 1,400 leaders of the historic preservation and community revitalization movements for its annual conference which was held in Detroit, MI, a city that is undergoing a dramatic and exciting turnaround. The conference provided attendees with instruction on a variety of topics, ranging from historic building rehabilitation and design, organizational development issues, and strategies for successfully implementing the Main Street Four-Point Approach (continued on Schedule O)
