MURPHY CENTER - SERVE 6 8 owns and operates the daily operations of The Sister Mary Alice Murphy Center for Hope (Murphy Center) The Murphy Center is a collaboration of over 30 organizations, creating a one-stop shop of resources for those experiencing varying degrees of poverty, including homelessness and near homelessness On average, the Murphy Center serves approximately 2,000 unduplicated guests every year, with 1,400 of those being new guests Every day the Murphy Center sees approximately 150 guests, which equates to about 37,500 visits a year The Murphy Center also provides about 4,000 showers to guests and 1,600 loads of laundry a year
