

Reason for late filing:

The management of The Thirteen Chamber Choir assumed that the filing date of this Form 990-EZ was May 15, 2015, even though the fiscal year ended on June 30, 2014. Having filed Form 1099's, for calendar year payments to independent contractors even though they were made in two different fiscal years, we mistakenly thought the organization's tax return would be handled in a similar fashion. When it was discovered in January 2015 that the return for the fiscal year ending June 30, 2014 should have been filed by November 15, 2014, we began prompt work on this Form 990-EZ in an effort to have it filed as soon as possible. We apologize for our misunderstanding of the filing deadlines and respectfully ask that any penalties for the late filing be abated. We understand that the Form 990-EZ for the fiscal year ending June 30, 2015 will be due by November 15, 2015, unless we file for a 3-month automatic extension which would make the return due by February 15, 2016.
