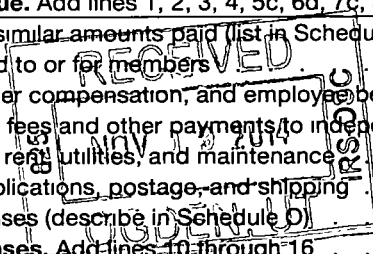



Part III: Because the Institute was not awarded a commission to develop and operate a public charter school in the District of Columbia, it has changed its purpose. Its principal purpose is to conduct research and studies, and publish information about the importance of enabling lower income students to acquire skills and knowledge to enable them to work well in a fulfilling vocation.

Part V, Line 34: The Institute changed its name from Xcelerrator Institute Public Charter School, to Steps Institute. A copy of the Articles of Amendment is attached.

Part VI, Lkine 48: Schedule E is not required because the Institute anticipated being a public charter school, funded by public funds. During 2015, the Institute will file Form 8940 to change its public charity status from Sec. 170(b)(1)(A)(ii) to Sec. 509(a)(1) and Sec. 170 (b)(1)(A)(vi)
