	PROVIDE SCHOLARSHIP FUNDS TO INCREASE THE ACADEMIC EXCELLENCE OF THE STUDENT BODY AND THE QUALITY OF THEIR EDUCATIONAL EXPERIENCE DURING THE FISCAL YEAR ENDED JUNE 30, 2014, THE UNIVERSITY OF SOUTH DAKOTA FOUNDATION ("FOUNDATION") PROVIDED \$11,340,360 MONETARY SUPPORT TO THE UNIVERSITY OF SOUTH DAKOTA ("USD"), PLUS \$99,813 TO SUPPORT FUNDRAISING EXPENSES OF USD'S DEAN. INCLUDED IN THIS AMOUNT WAS SCHOLARSHIP SUPPORT IN THE AMOUNT OF \$6.4 MILLION. SCHOLARSHIPS ARE AWARDED FOR BOTH RECRUITING AND RETENTION PURPOSES. A NEW FRESHMAN RECRUITING SCHOLARSHIP PROGRAM WAS STARTED IN 2003 THAT HAS BEEN INSTRUMENTAL IN HELPING TO ACCOMPLISH USD'S ENROLLMENT OBJECTIVES. THE AMOUNT OF SCHOLARSHIPS PROVIDED SINCE THIS NEW PROGRAM BEGAN HAS INCREASED FROM \$1.9 MILLION TO \$6.4 MILLION. ENROLLMENT INCREASED 27% SINCE 2003, WITH FIRST-TIME FULL-TIME FRESHMAN INCREASING BY 19%. THE NUMBER OF FRESHMAN FITTING THE ACT REQUIREMENTS TO RECEIVE THE SCHOLARSHIP INCREASED 27% DURING THIS PERIOD OF TIME. THE RETENTION RATE ALSO CONTINUES TO INCREASE AS A RESULT OF THE FRESHMAN SCHOLARSHIP PROGRAM.
