Each weekday, Dr. Munro helps listeners get a solid grasp of biblical principles and to find ways to apply them to real life. The program was aired on an average of 1,180 terrestrial radio outlets across the U.S. during the fiscal year. A 28-minute television version of previous broadcasts is also provided through the Web and on select television outlets. See Schedule O for continued program service description.
