The Phelps County Agricultural Society is affiliated with Phelps County government and receives tax funds from residents of the county. In 2013, tax funds received totaled \$116,772.

Part VIII, Line 1f - Other Contributions

Donations to the Agricultural Society included \$250 for Open Class special awards, \$950 for campers parked during the fair on the grounds, \$615 for assistance with fair activities, and \$425 in gifts for use of bleachers, the horse arena, and the horse trailer. A fund-raising campaign was begun in 2013 to replace the two old beef barns on the fairgrounds with an open-sided metal barn (to be erected by 2015). The following amounts were received in this fiscal year: \$5,000 from Cargill, \$10,000 from the Phelps County 4-H Foundation, \$2,600 from the Phelps County Memorial Hospital Foundation, \$9,500 from Farm Credit Services, \$6,810 from the Future Fund, and \$1,000 from the Bertrand Vet Clinic. The Phelps County Community Foundation also held a one-day give2Grow activity that brought \$87,710 in donations from 53 persons and businesses in the area.
