FIRST ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE KNIGHTS OF COLUMBUS PRO-LIFE FOUNDATION OF NEBRASKA, INC.

Pursuant to the Nebraska Nonprofit Corporation Act (Neb.Rev.Stat. §21-1901 et seq.), having no Members and, therefore, no need for Member approval, all Directors and Officers of the Corporation in office at the time of the special combined meeting held 24 May 2013 voted and unanimously adopted the following amendments to the Corporation's original Articles of Incorporation filed-stamped August 15, 1977 ("Articles"):

1. FIRST: The name of the Corporation shall be:

Knights of Columbus Culture of Life Foundation of Nebraska, Inc.

2. <u>SECOND</u>: The Corporation's Registered Office and Registered Agent shall at all times be the same as that on file with the Nebraska Secretary of State.

3. <u>THIRD</u>:

- A. The Corporation is formed under the provisions of the Nebraska Nonprofit Corporation Act and shall have all powers conferred by said Act and other applicable law. The nature of the business, objects, and purposes to be transacted, promoted, and carried-on are, generally, to receive and distribute donations, funds, and property to aid in the promotion, protection, and preservation of human life in all forms and to encourage a respect for the same. For all Corporate purposes, human life is the naturally animated existence of a person, either voluntarily or by natural human system functionality, from the moment of conception to natural death.
- B. Notwithstanding all other provisions set forth in the Articles and First Articles of Amendment, the Corporation's activities shall be limited at all times as necessary for the Corporation to qualify as an Exempt Organization as defined in Section 501(c)(3) of the Internal Revenue Code, as amended.

4. FOURTH:

- A. The Corporation is not formed for pecuniary or financial gain, and shall not issue and/or have capital stock, and shall not have members.
- B. No part of the net earnings of the Corporation shall inure directly or indirectly to the benefit of, or be distributable to the Corporation's trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions pursuant to and in furtherance of the business, objects, and purposes set forth in the THIRD Article herein.
- C. No part of the Corporation's activities shall consist of carrying on propaganda or otherwise attempting to influence legislation and/or participating or intervening in any political campaign on behalf of any candidate for public office.
- D. On the Corporation's dissolution, the Directors shall pay or make provision for payment of all Corporate liabilities and dispose of all Corporate assets pursuant to previous agreement and/or pursuant to the Corporation's purposes or to any organization(s) organized and operated exclusively for charitable, educational, religious or scientific purposes qualifying as an exempt organization under Section 501(c)(3) of the Internal Revenue Code (or future corresponding law). Any assets not so disposed of shall be disposed of by the District Court of the county in which the Corporation's principal office is then/was last located, exclusively for such purposes or to such organization(s) as said Court shall determine pursuant to law.
- 5. <u>FIFTH</u>: Management of the Corporation shall be governed by and vested in a Board of Directors defined by duly adopted Bylaws, as amended.

The undersigned Director, Officer, and Legal Counsel of the Corporation being duly authorized and directed by unanimous consent of the Corporation's Directors and Officers at the 24 May 2013 combined e-meeting hereby adopts and signs these First Articles of Amendment to the Corporation's Articles of Incorporation this 24th day of June, 2013.
