ARTICLES OF INCORPORATION
OF
UNEHEALTH**

These Amended and Restated Articles of Incorporation of UNeHealth, a corporation organized and existing under the Nebraska Nonprofit Corporation Act, Neb. Rev. Stat. §§ 21-1901 et seq., as amended (the "Act"), were adopted by the Board of Directors of the corporation, at a meeting on February 12, 2015, and approved by the Board of Regents of the University of Nebraska, at a meeting on April 10, 2015.

**ARTICLE I
NAME**

The name of the corporation shall be UNeHealth.

**ARTICLE II
DURATION**

The corporation shall have perpetual existence.

**ARTICLE III
PUBLIC BENEFIT CORPORATION**

The corporation is a public benefit corporation.

**ARTICLE IV
ORGANIZATION AND PURPOSES**

The corporation is organized and will be operated exclusively for one or more of the charitable, educational or scientific purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code ("Code"), including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code. Subject to the above, the specific purpose of the corporation shall be to provide for collaboration, strategic planning, coordination and joint decision making and implementation of policies and initiatives designed to promote effective and efficient quality health care, health care-related services, research, education and health promotion and wellness in furtherance and support of the mission and exempt health care purposes of the University of Nebraska Medical Center, the academic health sciences component of the Board of Regents of the University of Nebraska, its hospital partner and primary teaching hospital of the University of Nebraska Medical Center, and its integrated medical practice units under the University of Nebraska Medical Center College of Medicine Medical Service Plan.

ARTICLE V
POWERS

The corporation shall have and possess all powers and rights conferred by the laws of Nebraska upon corporations organized under the Act, and under Neb. Rev. Stat. §§ 71-2056 et. seq. relative to cooperative ventures by public hospitals, including any additional powers conferred by the laws of the State of Nebraska enacted after the date hereof, which an organization exempt from tax under Section 501(c)(3) of the Code may possess or exercise.

ARTICLE VI
MEMBERS

The corporation shall have no members.

ARTICLE VII
BOARD OF DIRECTORS

The business and affairs of the corporation shall be managed by a Board of Directors as provided in the Bylaws.

ARTICLE VIII
CORPORATE OPERATING REQUIREMENTS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, nor intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE IX
LIABILITY AND INDEMNIFICATION

The directors and officers of the corporation shall not be liable for the debts, liabilities, or obligations of the corporation, and the private property of such persons shall not be subject to the payment of corporate debts.

The corporation shall indemnify each person who serves or has served as a director or officer of the corporation to the extent permitted under Neb. Rev. Stat. §§ 21-1904(14) and 25-21,190, et. seq. Moreover, any person who serves as a director or officer of the corporation shall be indemnified from and against any civil liability or damages for any act or omission which results in damages or injury if such person was acting within the scope of his or her official functions and duties as a director or officer (unless such damage or injury was caused by the willful or wanton act or omission of such director or officer).

ARTICLE X
DISSOLUTION

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, distribute all of the net assets of the corporation exclusively for charitable, educational or scientific purposes within the meaning of Section 501(c)(3) of the Code, or to the federal government, or to a state or local government, for public purposes, as the Board of Directors shall determine. Any assets not so disposed of shall be disposed of by a court of equity in the county in which the registered office of the corporation is then located exclusively for the purposes identified herein or to such organization(s) which are organized and operated exclusively for such purposes as said court shall determine.

ARTICLE XI
APPROVAL OF CERTAIN ACTIONS

The approval of the Board of Regents of the University of Nebraska shall be required to adopt or approve the following actions:

- (1) to liquidate or dissolve the corporation;
- (2) to merge, consolidate, or transfer substantially all of the assets of the corporation.


ARTICLE XII
AMENDMENT OF ARTICLES OF INCORPORATION OR BYLAWS

The approval of the Board of Regents of the University of Nebraska shall be required to amend, in whole or in part, the Articles of Incorporation or the Bylaws of the corporation.

**AMENDED AND RESTATED
BYLAWS
OF
UNEHEALTH**

**ARTICLE I
OFFICES**

Section 1. Principal Office. The principal office of the corporation shall be located in the City of Omaha, Douglas County, Nebraska. The corporation may have such other offices, either within or without the State of Nebraska, as the Board of Directors may designate or as the business of the corporation may require from time to time.

Section 2. Registered Office and Registered Agent. The corporation shall have and continuously maintain a registered office in the State of Nebraska and a registered agent whose office is identical to such registered office. The registered agent and the address of such registered office may be changed by the Board of Directors.

**ARTICLE II
DIRECTORS**

Section 1. Number. The number of Board of Directors shall consist of five directors who shall consist of those persons who hold the positions described in Section 2 hereof.

Section 2. Delineated Positions. The members of the Board of Directors shall consist of those persons who hold the positions set forth below (the "Delineated Positions"), including any person who holds a Delineated Position on an interim or acting basis, while and so long as such persons hold said Delineated Positions and do not in writing either decline to serve as directors or resign. In the event that a person serving as a director no longer holds a Delineated Position, he or she shall no longer be a director and the person who succeeds to such Delineated Position shall become a director on the date of his or her appointment to the Delineated Position. In the event that a person who holds a Delineated Position declines in writing to serve as a director, resigns, or is otherwise unable to serve as a director, no director shall replace or succeed such person until such person no longer holds the Delineated Position.

The following are the "Delineated Positions" (exact title or functional equivalent):

1. Chancellor, University of Nebraska Medical Center ("UNMC");
2. Vice Chancellor for Business and Finance, UNMC;
3. Vice Chancellor for Research, UNMC;
4. President or CEO of Nebraska Medicine;

5. Dean, UNMC College of Medicine;

In the event any Delineated Position is abolished, the successor position to such abolished position, as determined by the Board of Directors, shall become a Delineated Position. If a Delineated Position is abolished and no successor position exists or is created, the Delineated Positions shall consist only of the remaining delineated positions set forth in the Articles of Incorporation (as amended).

Section 3. Chair. The Chancellor of the University of Nebraska Medical Center shall serve as Chair of the Board of Directors of the corporation.

Section 4. Removal. The Board of Directors shall not have the authority to remove a director.

Section 5. Resignation. Any director, by notice in writing to the Board of Directors, may resign at any time.

Section 6. Quorum. A majority of the number of directors comprising the Board of Directors, as set forth in Article II, Section 1 of these Bylaws, shall constitute a quorum for the transaction of business at any meeting of the Board of Directors.

Section 7. Meetings of Directors. The Annual Meeting of the Board of Directors shall be held at such date, time and place within the first six months following the end of the fiscal year of the corporation as may be fixed by the Board of Directors, or by an officer of the corporation authorized by the Board of Directors, and as stated in the notice of the meeting. Special meetings of the Board of Directors may be called by the President, or in the case of the President's absence, death or disability, by the Vice President; by the directors by action at a meeting; by a majority of the directors acting without a meeting; or by any director.

Section 8. Place of Meetings. Meetings of the Board of Directors shall be held at the principal office of the corporation unless the Board of Directors determines that a meeting shall be held at some other place within or without the State of Nebraska and causes the notice thereof to so state.

Section 9. Notice of Meetings. Written notice of the time and place of each meeting of the Board of Directors shall be given by the Secretary or the person or persons calling the meeting not more than thirty (30) days nor less than five (5) days before the date of such meeting to each director. Notice of any meeting shall be considered given if mailed or otherwise sent or delivered in writing to the director at the address specified in the records of the corporation. The giving of notice shall be deemed to be waived by any director who shall attend

and participate in such meeting without protesting, prior to or at the commencement of such meeting, the lack of proper notice and may be waived, in writing, by any director, either before, at or after such meeting.

Section 10. Voting. Except as otherwise specifically provided in these Bylaws or the Articles of Incorporation, or as is required by law, action approved by the affirmative vote of a majority of the directors present at a meeting at which a quorum is present shall be the action of the Board of Directors.

Section 11. Powers. The Board of Directors shall have general charge of the affairs, property, and assets of the corporation. It shall be the duty of the directors to carry out the aims and purposes of the corporation and, to this end, to manage and control all of its property and assets.

Section 12. Committees. The Board of Directors may create an Executive Committee comprised of members of the Board of Directors, and such other committees, including standing committees, as the Board deems appropriate from time to time. The Board of Directors may delegate to any committee which consists solely of directors any of the authority of the Board of Directors. Each committee shall serve at the pleasure of the Board of Directors, shall act only in the intervals between meetings of the Board of Directors and shall be subject to the control and direction of the Board of Directors. Each committee shall act by not less than a majority of the whole authorized number of its members.

Section 13. Action Without a Meeting. Any action which might be taken at any meeting of the Board of Directors or of any committee thereof may be taken without such meeting by a writing or writings signed by all of the directors or all of the members of such committee, as the case may be. The writings or writing evidencing such action taken without a meeting shall be filed with the Secretary of the corporation and inserted in the permanent records relating to meetings of the Board of Directors.

Section 14. Meetings Held Through Communications Equipment. Meetings of the Board of Directors or any committee of the Board of Directors may be held through communications equipment if all persons participating can hear each other, and such participation shall constitute presence at such a meeting.

ARTICLE III **OFFICERS**

Section 1. Number and Qualification. The officers of the corporation shall shall be a President/Chief Executive Officer, Vice President, Secretary, and

Treasurer. Any two or more offices may be held by the same person, except the offices of President and Secretary and President and Vice President.

Section 2. Election and Term of Office. The officers of the corporation shall be elected annually by the Board of Directors at the annual meeting of the Board of Directors. Each such officer shall hold office until the annual meeting of the Board of Directors next following the election of such officer and until such officer's successor shall have been elected and shall have qualified or until such officer shall resign or shall have been removed in the manner hereinafter provided.

Section 3. Removal. Any officer or agent elected or appointed by the Board of Directors may be removed by the Board of Directors whenever, in its judgment, the best interests of the corporation would be served thereby, but such removal shall be without prejudice to the contract rights, if any, of the person so removed.

Section 4. Vacancies. A vacancy in any office elected or appointed by the Board of Directors, due to death, resignation, removal, disqualification or otherwise, may be filled by the Board of Directors for the unexpired portion of the term.

Section 5. President & Chief Executive Officer. The President and Chief Executive Officer shall be the principal executive officer of the corporation and, subject to the control of the Board of Directors, shall in general supervise and control all of the business and affairs of the corporation. The President may sign, with the Secretary or any other proper officer of the corporation thereunto authorized by the Board of Directors, any deeds, mortgages, bonds, contracts, or other instruments which the Board of Directors has authorized to be executed, except in cases where the signing and execution thereof shall be expressly delegated by the Board of Directors or by these Bylaws to some other officer or agent of the corporation, or shall be required by law to be otherwise signed or executed; and in general shall perform all duties incident to the office of President and such other duties as may be prescribed by the Board of Directors from time to time.

Section 6. Vice President. The Vice President shall perform such duties and have such authority as from time to time may be delegated by the President or the Board of Directors. In the event of absence, death, inability, or refusal to act by the President, the Vice President shall perform the duties and be vested with the authority of the President.

Section 7. Secretary. The Secretary shall: (a) keep the minutes of the proceedings of the Board of Directors in one or more books provided for that purpose; (b) see that all notices are duly given in accordance with the provisions

of these Bylaws or as required by law; (c) be custodian of the corporate records; and (d) in general, perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned by the President or by the Board of Directors.

Section 8. Treasurer. If required by the Board of Directors, the Treasurer shall give a bond for the faithful discharge of the Treasurer's duties in such sum and with such surety or sureties as the Board of Directors shall determine. The Treasurer shall: (a) have charge and custody of and be responsible for all funds and securities of the corporation; (b) receive and give receipts for monies due and payable to the corporation from any source whatsoever, and deposit all such monies in the name of the corporation in such banks, trust companies, or other depositories as shall be selected in accordance with the provisions of these Bylaws; and (c) in general, perform all of the duties incident to the office of the Treasurer and such other duties as from time to time may be assigned by the President or the Board of Directors.

Section 9. Salaries. The officers of the corporation who are not otherwise employees of the corporation shall serve without compensation. Salaries for any employees of the corporation may be fixed from time to time by the Board of Directors in accordance with applicable tax law restrictions.

ARTICLE IV

CONTRACTS. CHECKS, DEPOSITS AND FUNDS

Section 1. Authorization. The Board of Directors may authorize any officer or officers, agent or agents of the corporation, in addition to the officers so authorized by these Bylaws, to enter into any contract or execute and deliver any instrument in the name of and on behalf of the corporation, and such authority may be general or confined to specific instances.

Section 2. Signatures. All checks, drafts, or orders for payment of money, notes, or other evidences of indebtedness issued in the name of the corporation, shall be signed by such officer or officers, agent or agents of the corporation and in such manner as shall from time to time be determined by resolution of the Board of Directors. In the absence of such determination by the Board of Directors, such instruments shall be signed by the Treasurer and countersigned by the President or a Vice President of the corporation.

Section 3. Deposit of Funds. All funds of the corporation shall be deposited from time to time to the credit of the corporation in such banks, trust companies, or other depositories as the Board of Directors may select.

Section 4. Contributions. The Board of Directors may accept on behalf of of the corporation any contribution, gift, bequest, or devise for the general purpose or for any special purpose of the corporation.

ARTICLE V

MISCELLANEOUS PROVISIONS

Section 1. Seal. The corporation shall have no corporate seal.

Section 2. Fiscal Year. The fiscal year of the corporation shall begin on the first day of July and end on the thirtieth day of June of each year.

Section 3. Bonding. The Board of Directors may require, if desired, that all officers and employees of the corporation handling or responsible for corporate funds shall furnish adequate fidelity bonds. The premiums for such bonds shall be paid by the corporation.

Section 4. Audit. The Board of Directors may cause the corporate books to be audited at the close of each fiscal year by a firm of certified public accountants. The audit report, the corporate books of account, and the corporate records shall be available for inspection by the directors of the corporation.




