By state statute, K S A 46-248 through 46-252, all of the organization's administrative staff who are under employment contracts, must sign written statements of substantial interests, and submit them to the State of Kansas Governmental Ethics Commission. Executive staff do not vote on matters such as entering into contracts, so their compliance is dictated by state law. Board members who identify a conflict of interest on any issue are excused from the board meeting while discussion, deliberation and voting takes place on any issue identified as creating a conflict of interest. The Executive Director and other members of the board jointly carry out the responsibility of identifying potential conflicts and ensuring compliance with the bylaws and statutes.

The organization's President, Vice-President and Secretary-Treasurer meet in February every year with the Executive Director. Annually, the NFHS surveys all 51 state association executive directors, to gather data on salary and benefits information as well as other financial and operational data common to state associations. The three person executive committee develops a salary recommendation and benefit package for consideration by the full Board at its' annual March meeting. Each year, the entire membership of the Executive Board votes on the annual compensation and benefit package for the organization's Executive Director. That action last occurred in May 2014.
