The program provides an evidence-driven, holistic approach to academic success that begins with strong communities and a safe, positive learning environment inspiring students, educators and parents to greatness, while also bringing current school improvement efforts into a comprehensive focus. Based on Rachel Scott's vision to create an intentional "chain reaction of kindness and compassion" this 5-step model transforms schools into safe, caring and supportive learning environments essential for academic for academic achievement
