As the nonprofit fundraising are for MCC, the Foundation services over 43,000 students annually by addressing their financial and educational needs through scholarships, educational enhancement programs, and the improvement of learning facilities Many programs take place on the five MCC campuses around the metropolitan area including the annual Storytelling Celebration hosted by MCC Maple Woods The event draws 20,000 people to over 100 venues across the area celebrating the rich diversity of culture and history through telling stories The Foundation administers scholarship and endowments, sponsors alumni and donor recognition events, and leads the annual fundraising campaign Other projects include the Emergency Book Fund which provides assistance to students in purchasing needed text books and lab supplies, providing awards for art shows held at the Carter Art Center, and supporting activities and programs held on the various campuses and in the community throughout the year
