10% facts and circumstances test

The Virginia Lions Eye Institute Foundation (the “Foundation”) has historically met the public support test percentages required by Internal Revenue Code Section 509(a)(1). On the 2012 Form 990, the Foundation’s public support percentage was lower than 33 1/3% due mainly to a single, large bequest that the Foundation received from an individual donor in 2008 that has since generated significant investment income. In 2013, the Foundation again finds itself with a public support percentage that is less than 33 1/3%. Therefore, in accordance with the Instructions for Schedule A of Form 990 and consistent with the requirements of Treas. Reg. §1.170A-9(f)(3), the Foundation asserts that in 2013, it is a public charity by means of meeting the 10% plus facts and circumstances test of Section 509(a)(1).

The Foundation asserts that it currently meets the 10% plus facts and circumstances test of Section 509(a)(1) for the reasons outlined below.

Under the facts and circumstances test of Section 509(a)(1), an organization must (i) have at least ten percent (10%) public support, and (ii) show that it is organized and operated to attract public support on a continuous basis (Treas. Reg. §1.170A-9(f)(3)). The facts and circumstances outlined below demonstrate that the Foundation is organized and operated to attract public support on a continuous basis.

the organization’s percentage of public support is well over ten percent	Historically, the Foundation has met or exceeded 33 1/3% of public support. In 2013, the Foundation’s percentage of public support is 24.72 %.
support comes from a representative number of persons rather than a single family	The Foundation’s public support comes from a combination of nonprofit organizations and individual donations. The majority of the Foundation’s public support comes from donations made by the various local Lions Clubs organized throughout the Commonwealth of Virginia. In fiscal year 2013, the Foundation received donations from 24 different Lions Clubs across the Commonwealth of Virginia. The Foundation believes that six of these contributing Lions Clubs are organized as 501(c)(3) organizations. In addition, the Foundation receives support from numerous individual donors, comprised of both Lions Club members and non-members alike. The Foundation’s public support is low because it receives a high percentage of its total support from investment income on its endowment funds. While that income is not public support, the original endowment was received as a bequest

	from a former founder and Board member of the Foundation. Although this donor was at one time an insider of the Foundation, because the donation came in the form of a bequest, the donor never exercised any undue influence over the Foundation as a result of this contribution. Recognizing the need to maintain and expand its sources of public support, the Foundation recently convened a special “Committee for Increasing Charitable Giving and Revenue” for the purposes of examining methods and developing strategies to increase the Foundation’s sources of public support. As part of the Committee’s efforts, it has identified various organizations which the Foundation has partnered and/or enjoyed support from in the past, including public charities, governmental agencies, membership associations, professional societies and various medical and educational foundations and associations. By renewing these associations with past partners and identifying new opportunities to partner with like-minded organizations that share or are aligned with the Foundation’s mission, and increasing its profile in the community, the Foundation intends to solicit funds from the general public, community, membership groups and other public sources in an effort to increase its public support.
the organization’s governing body is made up of a broad range of public interests, such as government officials or experts in the field	The Foundation has a diverse Board of Directors composed of doctors and other medical specialists having specialized knowledge and expertise in eye medical services and a variety of other medical fields. The Foundation Bylaws require that the Board of Directors include at least four (4) members “of the medical profession in the field of sight conservation” at all times. Currently, the Board includes five members who are ophthalmologists or optometrists.
the organization’s services or facilities are open to the general public on a continuous basis	One of the Foundation’s primary activities is its support of the Lions Eye Clinic at Fairfax Hospital. The Lions Eye Clinic provides free medical services exclusively to indigent patients and the Foundation routinely refers eligible individuals to the Clinic for treatment. Volunteer ophthalmologists offer their services to conduct examinations and provide treatment. All members of the public who are deemed eligible by the Fairfax County Health Department may receive treatment, free of charge, through the Lions Eye Clinic. In addition, the Foundation is actively involved in ensuring that state of the art medical equipment is available to eligible patients in need of eye medical services in Virginia. In order to determine the need for equipment, the Foundation conducts an annual inventory of each of the not-for-profit hospitals in

	Lions District 24-A, and makes inquiries with each hospital to identify any surplus and/or needed equipment. In the case of surplus equipment, the Foundation attempts to find a need and place the equipment in other hospitals. Through the cooperation of hospital administrators, cost-free transfers are facilitated. When additional equipment is needed and is not available through a transfer, the Foundation evaluates the need and within the limits of available funding, purchases the equipment either in whole or in part.
members of the public with special knowledge in the organization's field regularly participate in the organization's activities	Through the Foundation's work with the Lions Eye Clinic, eye specialists, such as ophthalmologists, volunteer their time, services and expertise by providing eye examinations, surgery and ancillary services to indigent patients at no cost to the patients. Supporting such a program furthers the Foundation's mission of supporting eye clinics that provide medical eye services, surgical eye services and prescription eye glasses to indigent patients. In addition, please see the explanation above regarding the special qualifications of the members of the Board of Directors.
the organization has a definitive programmatic structure	It is the Foundation's charitable mission to support eye clinics that provide medical eye services, surgical eye services and prescription eye glasses to indigent patients; to provide funding for low vision centers; and to provide educational grants to the blind. The Foundation achieves its mission, primarily by providing support to the Lions Eye Clinic at Fairfax Hospital in Northern Virginia. The Lions Eye Clinic at Fairfax Hospital provides medical eye services exclusively for indigent patients. This programmatic structure of an eye clinic for indigent patients has been in place since 1966 (which was before the date of the Foundation's incorporation in 1979). The Foundation has an active Board of Directors that oversees the Foundation's corporate governance and operations. It also has several Standing Committees, including but not limited to, a Fundraising Committee and Public Relations Committee, each of which actively participates in promoting the Foundation's activities in an effort to attract charitable contributions. In addition, the Foundation has recently convened a special "Committee for Increasing Charitable Giving and Revenue" for the purpose of developing strategies to increase the Foundation's sources of public support. Through the participation of its Directors, Committees and volunteers, the Foundation maintains a continuous program to

	solicit funds from the general public and the medical eye services community in support of the Foundation's programs.
the funding from public sources requires the organization to be financially accountable to those sources	The Foundation follows corporate formalities and internal controls generally recognized to provide for effective nonprofit governance. For example, the Foundation Bylaws require that the Foundation engage an independent CPA, on an annual basis, to prepare the financial statements of the Foundation. Copies of the independent financial statements are distributed to the members of the Foundation.
