SCWIB provides workforce development opportunities and resources in an eight county region of south central Pennsylvania. The agency oversees six Pa Careerlink Offices for job seekers and employers as defined in the Federal Workforce Investment Act. The SCWIB focuses on contracting with programs that enable employees, dislocated workers, welfare, EARN participants, and youth to master the job skill competence required by employers.

The organization expended federal Workforce Investment Act formula Title 1 and discretionary grant monies to enroll 3,099 adult, youth, and dislocated workers in job training and job development services. Rapid Response, core and intensive job search and development activities were provided for major layoffs in the eight county south central region of Pennsylvania. Over 37,382 participants were eligible for those services which included workshops, on the job training and skill specific training. Initial core service, eligibility determination and assessment occur at one of the six One Stop Centers (PA Careerlinks) within the eight county south central PA region in accordance with the WIA Act. Program services fund Title I subcontractors providing case management, individual skills training tuition, and on the job training reimbursement. Eligible participants served included: 338 in-school youth and 191 out of school youth. Rapid Response individuals impacted by major layoffs, adult and dislocated workers: 483 adults and dislocated workers received tuition based training or on the job training and rapid response events were held for employee layoffs under the WARN notifications. Youth job placement is 98%, adult job retention rate is 88%, and the dislocated worker job retention rate is 91%, all meet State performance goals.

Federal and State grants were awarded to subcontractors to enroll 772 welfare TANF adult participants and joint jobs initiative programs over the twelve month fiscal period 45% or 346 participants claimed job placements of 20 or more hours per week.

The measurable job

retention rate was 59% or 204 of those placed who retained jobs for six months July 1, 2014 and thereafter. Work activities programs such as work experience for enrollees were funded for youth to attain life and job search skills. 145 out of school youth were added to services and 95 youth were extended for services from the prior year. Program activities were provided by subcontractors and certified youth for work.

The Department of Public Welfare contracted with the SCWIB to contract with subcontractors to provide special services to a population of recipients throughout PA. The services are provided in the following areas: Dress for Success, Community College Assistance Programs, Non-Custodial Parent Assistance Program, and Overcoming employment related barriers.

\$78,150 State grants funded industry partnerships, incumbent worker, and state training for manufacturing, logistics, and transportation, health and life sciences, and the building and construction clusters in Adams, Cumberland, Franklin, Dauphin, Perry, Juniata, and York Counties. Over 125 participants received employment and development or advanced training. \$78,150 was received in pass-thru grant award State Employment and Training, Industry Partnership, and the Incumbant Worker funds from Pennsylvania Department of Labor and Industry to be utilized on program services by educational and other non-profit organizations. The number of companies participating in the upgrade of job skills training by industry partnership are as follows: Advanced Manufacturing, 121; Education, 47; Health Care, 52; IT 171; and logistics, 77.
