THE MARYLAND FOOD BANK IS A NONPROFIT HUNGER-RELIEF ORGANIZATION, LEADING THE MOVEMENT TO END HUNGER THROUGHOUT MARYLAND. FOR MORE THAN 35 YEARS, THE MARYLAND FOOD BANK HAS PARTNERED WITH COMMUNITIES ACROSS THE STATE TO DISTRIBUTE FOOD TO INDIVIDUALS AND FAMILIES IN NEED. CONTINUED FROM PAGE 2, PART III, LINE 1 THROUGH CAREFULLY CRAFTED PROGRAMS, THE FOOD BANK AIMS TO MEET THE IMMEDIATE NEEDS OF MARYLANDERS WHILE SIMULTANEOUSLY WORKING TO FIND LONG TERM WAYS TO REDUCE HUNGER STATEWIDE. CURRENTLY DISTRIBUTING MORE THAN 100,000 MEALS A DAY, NEARLY 37 MILLION MEALS ANNUALLY, THE MARYLAND FOOD BANK WILL CONTINUE TO EXPAND ITS EFFORTS UNTIL HUNGER ENDS.

| ACCORDING TO THE LATEST FEEDING AMERICA MAP THE MEAL GAP REPORT, 773,200 MARYLANDERS ARE CURRENTLY FOOD INSECURE, UNCERTAIN OF WHERE THEIR NEXT MEAL IS COMING FROM COLLECTIVELY, THEY MISS 135 MILLION MEALS EACH YEAR THE MARYLAND FOOD BANK EXISTS TO BRIDGE THIS MEAL GAP, GATHERING AND DISTRIBUTING MASSIVE QUANTITIES OF FOOD TO FAMILIES IN NEED EACH YEAR, WHILE SIMULTANEOUSLY ENGAGING OTHER STAKEHOLDERS FROM THE PUBLIC AND PRIVATE SECTORS IN THE FIGHT TO END HUNGER (SEE SCHEDULE O FOR CONTINUATION) THANKS TO A STRONG NETWORK OF APPROXIMATELY 1,250 DISTRIBUTION PARTNERS, PANTRIES,
